

Terms and Conditions of "uHub plus 100GB Time Limited Offer"

- 1. uHub plus service and this "uHub plus 100GB Time Limited Offer" ("Offer") are provided by Hong Kong Telecommunications (HKT) Limited ("HKT").
- 2. This Offer will be held at HKT's designated dates and times between 8-30 January 2015 (collectively, "Promotion Periods", and each an "Promotion Period") the designated dates and times of each Promotion Period will be announced on uHub plus website on www.uhub.com at least one (1) day before the start of each Promotion Period.
- 3. This Offer is only available on a first-come-first-served basis with a limited quota of 1,000 successful registrants per day in the Promotion Periods, to eligible new user (who must also be an existing consumer customer of the designated NETVIGATOR broadband, eye, csl or 1010 services) who has successfully registered for and activated an uHub plus account in accordance with Clause 4 below.
